## Upcoming European Distribution Change

With this letter we would like to inform you that our distribution entity Coherent Rofin B.V. (CRBV) will be merged to our other distribution entity Coherent Europe B.V. (CEBV) as of **June 1, 2024**.

As a result, your existing supply arrangement with CRBV will be transitioned (legally taken over by way of a general succession) to CEBV. Going forward all sales and service business will be handled by CEBV.. All new orders should be issued to:
